    - Motion passed unanimously
- 3. Financial Report and Direction to Move Funding Between Categories**
  - a.** Amanda Grant presented the financial report, including current and projected distributions and expenditures.
  - b.** The Council discussed strategies to address funding differentials to support long-term sustainability.
  - c.** Direction was provided for detailed billing reports to be presented to the Council monthly.
- 4. Consideration and Adoption of Administrative Delegation of Authority**
  - a.** A motion was made and seconded to adopt the Administrative Delegation of Authority

  - b.** A motion was made and seconded to appoint El Paso County to provide project management/facilitation services in an amount not to exceed \$100,000 annually.
